SECTION VI. HEALTH HAZARD DATA

This product is not considered a carcinogen by IARC NTR ACGIH or OSHA.

Summary of Health Risks

and Symptoms of Exposure: May cause mechanical skin and eye irritation. Repeated and prolonged exposures to iron oxide dust may cause a benign pneumoconiosis called siderosis.

Principal Routes of Entry: Inhalation, ingestion, skin and eye irritation

Accute Effects: Causes mechanical skin and eye irritation.

Chronic Health Effects(s): Prolonged inhalation of iron oxide dust is known to produce a condition known as siderosis. On X-rays it appears to be a benign pneumoconiosis and is not associated with pulmonary fibrosis or disability unless there is concurrent exposure to other fibrosis-producing materials such as silica. The TLV is set to protect against siderosis.

Emergency and First Aid Procedures:

- Eye Contact: Flush eyes with generous amounts of water for at least 15 minutes. Call a physician if irritation persists.
- Skin Contact: Wash skin with mild soap and water.
- Inhalation: Remove to fresh air. Call a physician.
- Ingestion: If conscious, give large quantities of water to induce vomiting. Get medical attention.

SECTION VII. PRECAUTIONS FOR SAFE HANDLING, USE OR DISPOSAL

Spill / Leak procedures: Vacuum or use wet clean-up techniques and place waste material in closed container.

Waste management / disposal: Disposal must be made in accordance with Federal, State and local regulations. Pursuant to 40 CFR part 261 of the Resource Conservation & Recovery Act (RCRA). Regulations currently in effect, discarded Iron Oxide would not be classified as a hazardous waste.

Precautions to be taken

in handling and storing: For transportation emergencies, call CHEMTREC, 24 hour information service, (800) 424-9300.

Personal protective equipment:

- Goggles: Wear safety glasses or goggles to protect against dust particles.
- Gloves: Leather or rubber gloves.
- Respirator: Use of NIOSH approved dust respirator is recommended when exposure limits may be exceeded.

Workplace Considerations:

- Ventilation: Local exhaust ventilation to collector or containment recommended to control dust to below exposure limits.
- Safety Stations: An eye wash station should be available to the area of use.
- Other: In accordance with good industrial hygiene practice, avoid contact with skin, eyes or clothing. Avoid breathing dust. Keep away from food products. Keep container closed when not in use. Use with adequate, localized ventilation. Wash thoroughly after handling and before eating, drinking or using tobacco products.
